**WAIVER AND RELEASE FROM LIABILITY**

I recognize and expressly agree that participating in any sport or activity associated with athletics or dance is a dangerous activity. Further, I recognize that certain safety precautions must be followed, yet even strict adherence to those procedures does not guarantee nor does Laguna Dance Theatre guarantee Participant's safety.

**Waiver and Release from Liability:** In consideration of permission to use, today and on all future dates, the property facilities, staff, equipment and services of LAGUNA DANCE THEATRE. I, for myself, my heirs, personal representatives or assigns, do hereby release, waive discharge, and covenant not to sue LAGUNA DANCE THEATRE its directors, officers, employees and agents from liability **from any and all claims including the negligence of Laguna Dance Theatre, its officers, employees and agents**, resulting in personal injury, accidents or illnesses (including death), and property loss from, but not limited to participating in activities, classes, observation, and use of facilities, premises, or equipment.

**Assumption of Risks:** Participation by its very nature carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains, to 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions, to 3) catastrophic injuries including paralysis and death.

**I have read the previous paragraphs and I know understand, and appreciate these and other risks that are inherent in the activities made possible by Laguna Dance Theatre. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.**

**Indemnification and hold Harmless:** I also agree to INDEMNIFY AND HOLD Laguna Dance Theatre HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities including attorney's fees brought as a result of my involvement at Laguna Dance Theatre, and to reimburse them for any such expenses incurred.

**Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**Publicity:** I understand that on occasion, LAGUNA DANCE THEATRE takes photographs and makes audio or video tape recordings of children and/or adults involved in dance activities. Such photographs and audio/visual recordings may be used in the Laguna Dance Theatre publications promotional materials, and pertinent website.
